Driving/Parking Agreement 2017-2018 School Year

- 1. Students who drive to school are subject to the Random Student Drug Testing.
- 2. Vehicles should always be locked and secured while on school property. Students should take care to insure that valuables are not left unattended in their vehicles. The school is not responsible for stolen items or damage to vehicles while parked on school property.
- 3. Greenfield-Central High School reserves the right to tow any vehicle, at the owner's expense, that is illegally parked in violation of school rules/policy or that has been left unattended for more than 24 hours. Vehicles parked on school property without proper registration or identification (parking permit) may also be towed at the owner's expense.
- 4. Failure to obey driving and parking regulations on school grounds may result in a disciplinary action such as Tuesday School, Thursday School, suspension, or loss of driving privileges.
- 5. You are expected to display your parking permit from your rear view mirror. Parking will be on first come/first serve basis. There will be no assigned spots. If you do not have a parking permit and you are parked in the parking lot, you will be assigned a consequence and/or towed. Replacement permits will cost \$5.
- 6. Students who park on school grounds agree to and understand that an inspection/search of vehicles parked on school grounds may be conducted if an assistant principal, principal, assistant superintendent, or superintendent have reasonable suspicion to believe that an inspection is necessary to prevent, impede, or substantially reduce the risk of:
 - a. Interference with school purposes or education function.
 - b. A physical injury or illness to any person.
 - c. Damage to personal or school property.
 - d A violation or state law or school rules

The following are examples of circumstances justifying the search of a car parked on school property:

- Reasonable grounds to suspect that a student is in possession, using, transmitting, or under the influence of any narcotic drug, hallucinogenic drug, amphetamine, barbiturate, marijuana, hashish, alcoholic beverage, look-a-like, counterfeit substance, controlled substance, or intoxicant of any kind.
- Reasonable grounds to suspect that a student is engaging in the selling of a controlled substance or other violations of criminal law which constitutes a danger to other students, or constitutes an interference with school purposes or an educational function.
- Where student's violence or threats of violence creates a reasonable belief that weapons may be stored in a student's car.

Driving/Parking Regulations:

- 1. All students will receive a numbered parking tag. Parking will be on a first come/first serve basis. Parking spots will not be assigned.
- 2. Students must park in areas designated as **student** parking. **No parking in staff parking areas on the east, west, or south sides of the building.**
- 3. Students must properly park between the lines of parking spaces.
- 4. Students must observe a speed limit of 15 MPH.
- 5. Students must observe all safety regulations as established by the State of Indiana and local ordinances related to the safe operation of a vehicle.
- 6. No smoking on school grounds. The Greenfield-Central smoking ban includes smoking in vehicles while parked on school property.

Where and How to Purchase Your Parking Permits at G-CHS

If you are going to be driving to school this fall, or will be getting your license at some time during the school year 2017-2018, you need to be aware of how to get your parking permit for your car. If you currently have your license, fill out the enclosed parking forms and bring them with you the first day of school, along with a check made payable to G-CHS. Parking permits are only \$20.00. These forms will be turned in during lunch in the cafeteria. There must be a parent and student signature on the form or you will not be able to purchase a parking permit. In addition, you must have the Random Student Drug Testing waiver on file with the school before you can receive a parking permit. Random Drug Testing waivers must be completed online through RankOne. If you will be getting your license during the school year, you may fill out the papers and purchase a parking permit in the Treasurer's Office at that time.

If you are going to be driving to WCC (Walker Career Center) you will need their parking tag in addition to a GCHS parking permit. WCC tags will be purchased at Walker Career Center.

The deadline for having parking permits this year will be Monday, **August 21, 2017.** By this date, the G-CHS Administration expects every current student driver to have their parking permit on their car. **Parking permits need to be hung from your rear view mirror.**

Important Dates to Know:

- August 3-18 Registrations accepted (driving form, drug testing consent)
- August 21- Parking is enforced. Students that do not have a parking tag will be given a consequence
