

GREENFIELD-CENTRAL HIGH SCHOOL 2020 DRIVER'S EDUCATION CONTRACT

MUST BE 15 YEARS OLD BY THE FIRST DAY OF CLASS. MY BIRTHDATE IS _____

The new Indiana Graduated Driver Licensing Law requires the student to be 15 years old before they can start any part of the Driver's Education program, including class time and drive time. Students will receive instruction at the first classroom/online session on how to obtain a Driver education permit. Students will be required to pass a written test at the BMV before the driving permit is issued.

Indiana state law requires each student to complete 30 hours of classroom instruction and 6 hours of behind-the-wheel in car instruction. In addition, Greenfield-Central High School provides students with in car observation time, up to 12 hours. Due to these specific time requirements, there are no tardies or excused absences.

Greenfield-Central will allow students to complete the classroom portion of the Driver's Education Program at Greenfield-Central High School **OR** online through the Central Indiana Educational Service Center (CIESC) Driver's Education Program. For students who choose the online course option, they will complete their driving with Greenfield-Central instructors in June during regular summer school.

<u>CLASS OPTION 1: GREENFIELD-CENTRAL CLASSROOM COURSE</u>

- The Greenfield-Central High School spring semester classroom course will begin on TUESDAY, JANUARY 14, 2020.
 Classes will meet on TUESDAYS AND THURSDAYS from 3:40 5:40 p.m. at G-CHS. The class will finish on March 3, 2020. The fee for the G-C Classroom Course is \$55.00, payable to Greenfield-Central High School.
- The Greenfield-Central High School summer classroom course will begin **June 3, 2020.** Students who take the course at this time will be assigned in car instruction after completion of the 30 hours of required classroom time.
- <u>CLASS OPTION 2: CENTRAL INDIANA EDUCATIONAL SERVICE CENTER ONLINE COURSE</u> Students must register for the online course at <u>http://driveredsafety.com/classrooms/driver-education-online</u>. Choose the classroom only option when registering. If you have questions, please contact CIESC at (317) 759-5560. The cost of the online course is \$55.00. Fees must be paid online when you register. Proof of successful completion is required prior to starting the G-C driving portion of the program.

IN CAR INSTRUCTION: The Greenfield-Central driving portion of the Driver's Education program will be offered in June during regular summer school hours. If your student is taking other summer school classes, please indicate that on the emergency form. (attached) It is the responsibility of the student and parent/guardian to avoid schedule conflicts with summer school. Due to the limited number of time slots, some requests cannot be honored. Students who successfully complete their classroom portion of the program will be given top priority in choosing drive times, if all fees are paid. **Course fees must be paid in full before scheduling in car instruction times.**

FEES: The fee for the Driver's Education Program is **\$365.00.** The program fees must be paid in full by April 17, 2020. If a student completes the classroom portion with CIESC, the cost for the in car instruction portion will be **\$310.00**. Payment for the CIESC online classroom portion will be made directly to CIESC. The Driver's Education program fee is **NON-REFUNDABLE**. If the student does not comply with attendance and discipline requirements or withdraws from the Driver's Education program and/or school, **no refunds will be issued**.

- January 10, 2020 \$200 deposit due for G-C winter classroom/CIESC online
- March 13, 2020 \$200 deposit due for G-C summer classroom
- April 17, 2020 remaining balance must be paid in full

Driver Education Frequently Asked Questions

1. Can I take PE in the summer and still take Drivers Ed?

Yes, you can. Summer PE class times are 8am until noon and the Driver Education class is from 1-3 pm. Your drive time would then be 3-5 pm on designated days. It makes for some long days and students cannot miss their Classroom or drive day. Not taking PE in the summer allows students to drive in the morning prior to the classroom portion. Students taking the classroom portion during the school year have better drive time opportunities available.

2. Is attendance mandatory?

It is in the classroom portion of the course. This class meets for 2 hours a day for 15 days to arrive at the required thirty hours of class instruction. Driving time can be made up through prior arrangements with the in-car instructor. Students are to arrive at GCHS prior to their assigned drive times.

3. Can a student change their drive time and day?

Students cannot change their assigned drive times. Students cannot trade with other students at any time. Drive time changes will only be coordinated between parents and the in-car instructor.

4. How do I enroll in the online class and drive with GCHS teachers?

Students can enroll in Indiana Online Academy (IOA) through Central Indiana Service Center (SIEC) for the classroom portion of the class. When enrolling, parents will choose the tab on the IOA website that is for the online class only. You will only be asked to pay for the classroom part with IOA and will pay Greenfield-Central Schools for the driving portion. If a parent pays the entire cost of the program to IOA, the student will then drive with an IOA instructor.

5. When can my student drive?

Most of the drive times are in the month of June. However, students can drive in May and July to accommodate special requests and needs.

6. When is the summer classroom session?

The summer classroom session starts the same day as regular Summer School and runs for three weeks.

7. Is the classroom portion offered at any time other than the summer?

Typically, students can take the classroom portion at Greenfield-Central High School in January and February. There have been years that a second class in April and May is needed. Students may take the online class with IOA at any time.

8. Where can I find information about Driver Education?

All information about Driver Education is on the Greenfield-Central High School

website. The information is updated in December for the following driving sessions. You can also contact GCHS with your questions.

9. Can I take the online portion with any provider?

At this time, we are only working with IOA to allow students to take the class online. We are aware that there are other online organizations offering Driver Education. Please check with Greenfield-Central High School prior to enrolling in any other provider.

10. How will students know when they are driving?

For the month of June, driving days and times will be posted around the high school during the last week of school. Students will also receive an email with this information included. Students will be told where to look for those lists. If a student is driving in May or July, parents will be contacted by the in-car instructor to arrange days and times for the driving.

11. My student does not attend Greenfield-Central Schools. Can they take the course? Currently only students in the Greenfield-Central Schools are allowed to take the course.
